Entry fees are due postmark May 24, 2013. There will be a 25% penalty assessed for payments postmarked after the deadline. Draw Date June 3, 2013.

Open: Those entering the Intermediate Open and/or Limited Open Divisions must pay \$450 per division and be entered in the Open Division. Those entering the Level 1 Limited Open do NOT need to enter the Open Division; it is a standalone division and will have its own draw. If the horse is entered in this class and in the Open division, the horse will show in the Open Draw and the score from the Open will be counted in the Level 1 Limited Open; horses will not have to run twice unless riders are not the same. The \$5K Novice Horse class will run concurrent with the Open division, but those entering the \$5K Novice Horse class do not need to enter the Open Division. **Non Pro** entries are automatically entered into all Non Pro divisions for which they are eligible (Intermediate Non Pro and Novice Non Pro only). Non Pro Money will be paid out 60% Non Pro, 30% Int. Non Pro, 10% Nov. Non Pro. Those entering the \$7500 Amateur Division do NOT need to be entered in the Non Pro Division. The Non Pro Limited division follows the same rules as the Horse Show Non Pro Limited eligibility (see Rule 10.4.12). The NRCHA Rule Book contains the rules for Limited Aged Events and the NRCHA Derby and will be followed as printed. Both owner and rider must be current 2013 NRCHA members. There will be a \$290 Finals Fee the Open divisions. Horses that make it back in multiple divisions will only pay one finals fee if concurrent. Entries are not valid without payment in full. 70% of entry fee goes to Pay Out.

In consideration for the right to participate in such activities, or any other activity that the registrant may participate in at the NRCHA Derby, registrant assumes the risk of injury or death of participating in those activities and hereby releases National Reined Cow Horse Association ("NRCHA") and its employees, representatives and all other agents associated with NRCHA from liability for any personal injury, property damage, or death that occurs from those activities. Registrant further agrees to release and hold harmless NRCHA its employees, representatives, agents and anyone else working at the event who through negligence or carelessness otherwise might be liable in damages to registrant. This release and waiver of liability shall be binding on Registrants heirs, representatives, dependants, and successors in interest. I have read and understand the terms and conditions of the entry into this event and agree to abide by those terms and conditions and the NRCHA Rule Book. I agree as a condition of in consideration of acceptance of entry the National Reined Cow Horse Association may use or assign photographs, videos, audios, cablecasts or other likeness of me and my horse taken during the course of competition for the promotion, coverage or benefit of the competition, sport or the NRCHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way to jeopardize Non Pro/Amateur status. I hereby expressly and irrecoverably waive and release rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity or to misappropriation. I have the authority and hereby do, by making this entry, assume responsibility for and bind owner, rider and/or agent to the terms and conditions of this Release and Waiver of Liability. I warrant that I am of legal age, or am the parent or legal guardian of the participant named above, and that I have read and fully understand the foregoing terms.
